**Trial Memoranda**

Any trial memoranda (optional), which will be in lieu of post-trial briefs unless otherwise requested by the Court at the conclusion of the trial.

**EXHIBITS**

Both parties shall present all exhibits to the Clerk of this division no later than **three (3) days prior to the trial or hearing date.
