IT IS FURTHER ORDERED that the parties shall participate in a mandatory Settlement Conference. The Office of Alternative Dispute Resolution will not do the scheduling of the settlement conference so please do not contact that office. If counsel prefer to use a private mediator to conduct the Settlement Conference, a Stipulation and Order Re: Alternative to ADR must be presented to the Court.

IT IS FURTHER ORDERED setting a Telephonic Status Conference in this matter on **December 4, 2014 at 8:45 a.m.** (time allotted: 15 minutes) in this division. Counsel for the Plaintiff shall initiate the conference call.
