Mr. Slavin states that he and new counsel for Defendants, Philip May have conferred and will file their Joint Report and [proposed] Scheduling Order soon.

IT IS ORDERED the parties shall file their Joint Report and [proposed] Scheduling Order by not later than **June 24, 2024**.

Mr. Slavin states that the parties jointly moved the Court to continue the case on the Dismissal Calendar in order to allow Defendant's counsel to have more time to meet with her client. Judge Agne granted the parties' request on May 30, 2024 to extend the matter until June 11, 2024.

Mr. Slavin requests that the Court extend the matter on the Dismissal Calendar through **June 28, 2024**.
