MINUTE ENTRY

The Court has received and reviewed Plaintiff's Motion for Alternative Service Upon Defendant Joselito Espinoza.

Plaintiff requests relief citing to Rule 4.1(m), one of the publication provisions but asks for alternative service more consistent with Rule 4.1(k). This latter provision requires that reasonable efforts be made to provide actual notice to Defendant of the action. Under the circumstances, it does not appear that actual notice will be provided to Defendant Joselito Espinoza by alternative service.

IT IS ORDERED that Plaintiff's Motion for Alternative Service is denied without prejudice.
