MINUTE ENTRY

The Court has reviewed Defendant Nancy Berent's newest filing captioned "*Superior Court Administration Rule 91 e Violation Rule 93 b Violation since Dec 21 2021 Motion is Still Pending*" (filed 8/6/24). Plaintiff apparently believes that a motion filed on December 21, 2021 remains pending and asks Court Administration to prepare a list and report.

This case with dismissed with prejudice on November 7, 2017 because the Court received notice that the matter had settled and the parties and complied with the terms of the settlement agreement. The Court denied all pending motions including a motion to enforce a settlement agreement as moot. The Court entered a final judgment of pursuant to Rule 54(c) of the Arizona Rules of Civil Procedure.

Prior to dismissal, on October 17, 2017, Defendant filed a Notice of Appeal (NOA) in this cause number. The NOA was jointly filed in cause numbers CV2017-052655, LC2018-000464-001, and LC2021-000100-001.

On January 24, 2024, the Court of Appeals issued a memorandum decision in the appeal. *See Berent v. Mroczkowska*, 2024 WL 492177, n. 3 (January 4, 2024). The Court of Appeals affirmed the trial court and expressly noted that the parties raised issues only in CV 2017- 052665 which, of course, is not this case. *Id.* at n. 3. Thus, Defendant's inclusion of this cause number in the NOA was a ministerial error.

On July 22, 2024, the Court of Appeals issued its mandate.

Having reviewed this file, the Court finds that this case has been completed since 2017. Further, the docket does not reflect any motion was filed on December 21, 2021. Accordingly, the Court will take no action on Defendant Nancy Berent's filing captioned "*Superior Court Administration Rule 91 e Violation Rule 93 b Violation since Dec 21 2021 Motion is Still Pending*" (filed 8/6/24).
