Counsel, Barry Becker, has submitted a "Motion to Appear Telephonically". This motion is dated September 7, 2006. This motion relates to a hearing scheduled for October 5, 2006. The Court makes note of the following.

- The Court appreciates Mr. Becker taking the time to advise the Court of a potential conflict.
- This division would generally give priority to a Superior Court hearing over an arbitration hearing (absent some special circumstances).
- The Court cannot rule out the possibility that testimony will be presented at the October 5 hearing.
- Given the limitations of the Court's equipment, telephonic participation by an attorney in an evidentiary hearing has generally been unsatisfactory to the Court and the person attempting to participate telephonically.
- Although the Court is not anxious to continue the above discussed hearing, under the circumstances known to the Court, if there is a real possibility counsel will not be able to participate in the hearing, a continuance would be preferred to a telephonic appearance of counsel.
