MINUTE ENTRY

The Court makes note of the following:

- Plaintiffs filed their original Complaint on January 17, 2014.
- Through a Minute Entry dated June 4, 2014, pursuant to a request filed by Plaintiffs, the Court extended the service deadline to September 11, 2014.
- Through a Minute Entry dated July 31, 2014, on Court's own motion, the Court extended the service deadline to September 30, 2014.
