MINUTE ENTRY

The Court received and reviewed Plaintiff's First Application for Post-Judgment Attorneys' Fees and Costs of Collection (the "Application"). In a recent reported decision, the Arizona Court of Appeals held that attorneys' fees incurred related to tasks "such as obtaining the debtor's employment information" are only recoverable pursuant to A.R.S. § 12-1598.07(E), which is not applicable at this time in this matter. *Ironwood Commons Community Homeowners Association, Inc. v. Randall*, 1 CA-CV 17-0381, 2019 WL 1487076, at *5 (App. Apr. 4, 2019). The Application filed in this case includes time entries for tasks related to the judgment debtor's employment. Accordingly,

IT IS ORDERED denying the Application without prejudice to be refiled with the employment-related time entries removed.
